HONORABLE ROBERT J. JONKER, CHIEF UNITED STATES DISTRICT JUDGE

UNITED STATES DISTRICT COURT FOR THE WESTERN DISTRICT OF MICHIGAN

President George W. Bush appointed Robert (Bob) Jonker to be United States District Judge for the Western District of Michigan on July 16, 2007, to succeed the Honorable Gordon J. Quist, who assumed senior status on January 1, 2006. Judge Jonker assumed his duties on July 18, 2007. Judge Jonker was elevated to Chief Judge of the United States District Court for the Western District of Michigan on July 18, 2015.

Before taking the bench, Judge Jonker practiced commercial and environmental litigation for twenty years with the law firm of Warner Norcross & Judd LLP. His work included cases at all levels of the Michigan courts, and at all levels of the federal courts throughout the country. He was listed in *Best Lawyers in America* for business litigation.

Judge Jonker graduated with honors from Calvin College in 1982, and *summa cum laude* from the University of Michigan Law School in 1985, where he was Order of the Coif. Before leaving law school, he worked as a research assistant to Professor James J. White, which contributed to a career long interest in commercial and bankruptcy law issues. Immediately following law school, Judge Jonker worked for two years as a law clerk for the Honorable John Feikens of the United States District Court for the Eastern District of Michigan. In 2010 Judge Jonker was appointed to the United States Judicial Conference Advisory Committee on Bankruptcy Rules and served two three-year terms.

JACKIE STASIAK, DETECTIVE SERGEANT

D/Sgt. Jacque Stasiak has been with the Michigan State Police for over 25 years. Her current assignment includes supervision of the criminal casework of the 50+ troopers at the Rockford Post, encompassing Kent, Ottawa and Muskegon counties, as well as major case investigations to include: homicides, death investigations, sexual assaults, computer crimes and frauds. She has been a member of the FBI's West Michigan Based Child Exploitation (WebChex) Task Force since 2014 investigating child sex abuse and human trafficking cases. She is currently assigned on an Investigative Response Team which investigates Officer Involved Shootings in the West Michigan area.

D/Sgt. Stasiak has spent her entire career with the Michigan State Police in the West Michigan area, having worked at the Rockford Post (1993-1998), Metropolitan Enforcement Team (1998-2000), Lakeview Post (2000-2001), Ionia Post (2001-2016), Kent Metro Cold Case Team (2006) and returned to the Rockford Post in 2016. She has specialized in child sex crimes, having become forensically certified to interview children in 1997. She has interviewed hundreds of child victims and witnesses since that time. She is one of the incorporators of a Child Advocacy Center, the IMSAFE CAC, which services both Ionia and Montcalm counties and was fundamental in bringing that resource to the Ionia/Montcalm community. D/Sgt. Stasiak remains on the board at that IMSAFE CAC as well as the fundraising committee.

Russ Kavalhuna

PRESIDENT, HENRY FORD COLLEGE/FORMER ASSISTANT UNITED STATES ATTORNEY

Russell A. Kavalhuna joined Henry Ford College as the institution's sixth president in July 2018. The role unites his passions for public service, education, and institutional leadership. He believes community college is the gateway to the American Dream. Kavalhuna was previously the Executive Director of the Western Michigan University College of Aviation, the nation's third-largest collegiate aviation program with operations in Michigan and Florida.

Prior to his position at WMU, Mr. Kavalhuna was an attorney and a commercial airline pilot. He served as a federal prosecutor for the U.S. Department of Justice in Grand Rapids, where he managed more than 140 officers in a multi-year investigation and prosecution of 31 gang members. He was a senior lawyer in the Michigan Supreme Court, and he has taught at Western Michigan University Cooley Law School.

As a pilot, he captained for U.S. Airways Express for five years. He also held a leadership position in the Airline Pilots Association collective bargaining unit.

Mr. Kavalhuna earned his undergraduate degree in aviation science from Western Michigan University. He earned his juris doctor from WMU Cooley Law School, and has undertaken doctoral coursework in the "Institutional Leadership During Crisis" program at WMU. His awards and honors include the Airline Transport Pilot Certificate, the highest civilian license; the ATF National Honor Award for Prosecution of Organized Crime; the Outstanding Achievement Award from the Holland Police Department; and being named as an "Up and Coming Lawyer" by Michigan Lawyers Weekly.

HONORABLE PHILLIP J. GREEN, MAGISTRATE JUDGE

UNITED STATES DISTRICT COURT FOR THE WESTERN DISTRICT OF MICHIGAN

Hon. Phillip J. Green was appointed to an eight year term as United States Magistrate Judge on August 1, 2014. Prior to Judge Green's appointment, he worked as an Assistant United States Attorney, beginning his tenure there in 1998. While with the United States Attorney's Office, Judge Green served in various capacities including Senior Litigation Counsel, Deputy Chief of the Criminal Division, and First Assistant United States Attorney. Substantive areas of responsibility included white collar crime, health care fraud, tax, Indian Country Matters, and violent crime.

Prior to his service as an AUSA, Judge Green served the U.S. Department of Justice in Washington D.C. for a combined six years, was in private practice for one year, and served as a Law Clerk to Honorable Theodore McMillian at the Eighth Circuit Court of Appeals. Judge Green also served in the United States Navy from 1974-1976 and the United States Navy Reserves from 1976-1979.

Judge Green has also served as an adjunct and visiting professor at the Thomas M. Cooley Law School and currently as an adjunct professor at Ferris State University.

Judge Green attended Saint Meinrad College and graduated in 1982 with a B.A. He received his J.D. as first in class in 1990 from Saint Louis University School of Law where he graduated *magna cum laude* and was the Editor in Chief of the Saint Louis University Law Journal.

HONORABLE JANET T. NEFF, UNITED STATES DISTRICT JUDGE

Janet Theresa Neff, was born on April 8, 1945, in Wilkinsburg, Pennsylvania, the daughter of Pauline J. and Lino Nebiolo. Janet attended the University of Pittsburgh where she was elected to Omicron Delta Epsilon, an Economics Honorary Society, and graduated *cum laude* in 1967 with a B.A. Janet received her J.D. in 1970 from Wayne State University Law School.

Judge Neff has had a widely varied legal career beginning as a law clerk at the Michigan Court of Appeals. Other government service included service as an assistant city attorney for the City of Grand Rapids, Michigan, Commissioner for the Michigan Supreme Court, and assistant U.S. Attorney with the U.S. Attorney's Office, Western District of Michigan. Her private practice experience was conducted in two Grand Rapids law firms from 1973 to 1978 and from 1980 to 1988. She was elected to four terms and served more than 18 years as a Judge on the Michigan Court of Appeals.

President George W. Bush nominated Judge Neff to the United States District Court for the Western District of Michigan on March 19, 2007; she received her commission on August 6, 2007, succeeding Judge David W. McKeague who was elevated to the Sixth Circuit Court of Appeals. Judge Neff was the first woman Article III Judge to be appointed in the Western District of Michigan.

Active in professional and community organizations, Judge Neff holds memberships in the State Bar of Michigan where she served on the Board of Commissioners from 1980 to 1984, Grand Rapids Bar Association, Women Lawyers Association of Michigan, Western Region, Federal Bar Association, and Federal Judges Association.

Judge Neff served as the first woman President of the Grand Rapids Bar Association, after having served as Treasurer, Vice-President, and President Elect. She received the "Donald R. Worsfold Distinguished Service" award for 2018, the Women Lawyers Association of Michigan, Western Region "Outstanding Member" of 2006 award, and the "Law Enforcement" award for 1998 by the Order Sons of Italy in America Grand Lodge of Michigan. In addition, she was Honorary Co-Chair of the Habitat for Humanity Women Building the Dream Project, a house totally funded and built by women volunteers.

Judge Neff and her husband, David Neff, have two daughters, Genevieve Dorment of New York, Meredith Neff of Chicago, Illinois, and three grandchildren.
